

## Promotion Details

<b>Promotion Name</b>	<b>KRAFT TOOL CO REDEMPTION PROMOTION</b>
<b>Promoter</b>	The Promoter is Flextool, a division of Parchem Construction Supplies Pty Limited (ABN 80 069 961 968), located at 1956 Dandenong Rd Clayton 3168, Victoria, Australia.
<b>Promotion Type</b>	Redemption Promotion
<b>Promotion Period</b>	The Promotion will commence at 12.00am AEDST on 3/2/25 and close on 11:59PM AEDST on 31/3/25 ( <b>Promotional Period</b> ). Qualifying product(s) must be purchased during the promotional period. Claims for purchases made during the promotional period will be accepted till 11/4/25.
<b>Participating Channel</b>	The channel participating in the promotion are selected Flextool product distributors ( <b>Participating Channel</b> ). Distributors will display promotion materials. If in doubt, an claimant may ask a store whether or not they are participating in the Promotion.
<b>Redemption Restrictions</b>	<p>Redemption is only open to eligible claimants.
