## Schedule to Terms & Conditions of entry

<b>Eligible entrants</b>	<p>This Competition is only open to existing Repco &amp; Appco Trade account customer's only (resellers excluded) ('Eligible Entrant') only who: (a) are operating within New Zealand and are aged 18 years or older; (b) have not been discovered to have breached these Terms and Conditions, (c) has not pre-purchased the RPP190NZ Ryco promotion pack prior to the start of the promotion, 13/07/2020 at 8.00am.</p> <p>Eligible Businesses must be within the Promoter's trading terms throughout the promotional period and must not have overdue monies owing as at the promotional closing date in order to be eligible to claim any prize.</p>

<b>Method of entry</b>	<p>To be eligible to enter, customers must purchase a Ryco Promotional pack, <b>RPP190NZ</b> and must complete the following steps during the Promotional Period:</p> <ul style="list-style-type: none"> <li>a. Retrieve the Scratch &amp; Win Entry Instruction Card from the Ryco Promotional Pack (RPP189) listing the unique code. The entry card listing the unique code is proof of an eligible purchase and is required for entry. (“<b>Proof of Purchase</b>”)</li> <li>b. Visit the website <a href="http://www.winwithryco.com.au">www.winwithryco.com.au</a> (“<b>Website</b>”), input the requested details including unique code, full name, workshop name, Repco Invoice number, and mobile phone number, and;</li> <li>c. Submit the fully completed online entry form.</li> </ul> <p>Entrants will then be directed to play, via Website, the promotional ‘Scratch to Win’ game. The ‘Scratch to Win’ game will contain a blank panel which the entrant will need to use their finger (for mobile phones or tablets) or a computer mouse (for non-touch screen devices) to rub/traverse across the entire blank panel to reveal an instant prize. The instant win prize won by the entrant will be identified by revealing three (3) of the same prize image, (from the pool of instant win prizes on offer), and the entrant will win the prize indicated.</p>

## Terms & Conditions of entry

1. Information on how to enter and prize details form part of these terms & conditions (**Terms of entry**). The Terms must be read in conjunction with the Schedule. The Schedule defines the terminology used in these Terms of entry. Where there is any inconsistency between these Terms and the Schedule, the Schedule prevails. Participation in this Promotion is deemed acceptance of these Terms of entry.
2. Entry is open only to legal residents of New Zealand who satisfy the Method of entry. Directors, officers, management, employees, suppliers (including prize suppliers) and contractors (and the immediate families of directors, officers, management, employees, suppliers and contractors) of the Promoter and of its related bodies corporate, and of the agencies and companies associated with this Promotion, including the competition permit providers TPAL (Trade Promotions and Lotteries Pty Ltd) are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, child or stepchild (whether natural or by adoption), parent, stepparent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, stepbrother, stepsister or first cousin.

The Promoter is not liable for any consequences of user error including (without limitation) costs incurred. No correspondence will be entered.
13. The prize(s) will be awarded to the valid entrant(s) drawn randomly in accordance with the Prize draw details. The Promoter may draw additional reserve entries (and record them in order). In the event of an invalid entry or an ineligible entrant, or if the entrant is ineligible to accept the prize, the prize will be awarded to the first reserve entry drawn. If a prize is no longer available, the promoter may substitute with a prize of higher or equal value "subject to any written directions from a regulatory authority". Without limiting any of the foregoing, in no circumstances will an entrant or the Promoter have any liability to the other for any loss or damage suffered which is indirect or consequential in nature, including without limitation any loss of profit, loss of reputation, loss of goodwill, or loss of business opportunity.

23. The Promoter and its associated agencies and companies will not be liable for any damage in transit to or delay in transit of prizes.
24. The Promoter may in its absolute discretion not accept an entry, may disqualify an entry, or cancel the entire Promotion at any time without giving reasons and without liability to any entrants.
